- Fly Cars are minimally required to carry what is on the portable or fly car list. Items with a \* the ambulance amount must be carried on fly cars. These items do not need to be carried in a portable bag on a transport ambulance
- Transport ambulances are minimally required to carry what is on the portable or fly car list in a portable bag (enabling the meds/equipment to be brought to the patient). Ambulance list items can also be carried in a portable as well (must have total amount between both portable and ambulance list)
- A current NYS Department of Health Limited Service Registration is required for glucometry
- Dial a flow or gravity IV set training should be done per manufacturer recommendations
- We realize that all pharmacy's or medical suppliers may offer medications in different concentration and that is ok if you have a comparable milligram amount to what is listed.
